A. Sea Glass Cottages Phase II Landscape Plan

B. <u>Mainscape Proposals</u>

a. Cedar Tree Removal at Barefoot Shops

b. Wireless Rain Sensors

c. Removal of Dead Grass at Clubhouse

d. Zoysia Sod on Club Course Drive

This proposal has been tabled until Mainscape provides information regarding irrigation, mulch, and flower beds.

C. North Tower Pool 2023 Security Monitor

This item is tabled until Ms. White schedules the service with Off Duty Management to hire one (1) officer on Friday, Saturday, and Sunday from 12:00 p.m. through 10:00 p.m.; as well as, July 4th holiday, Easter, and Memorial holiday. The Board of Directors asked Ms. White to see if there is any rate reduction for a summer contract.

D. North Tower Pool Landscape and Lights
