# **Assets**

- **Cash-Operating Account:** \$71,330.91 is the amount of cash in the operating checking account at the end of the month.
- **❖ Pre-paid Insurance:** \$6,333.30 is the amount paid to the insurance company prior to the renewal date of August 1, 2024.

#### Liabilities

❖ Accounts Payable: \$24,397.49 is the "open payables" at months' end, which means that invoices for expenses incurred during the month were keyed; however, paid the following month.

- ❖ Prior Year Operating Fund Balance: \$0 in excess income over expenses at the end of the 2022 fiscal year.
- **❖ Total Net Income:** \$53,266.72 is the amount of income over expenses at month's end.

# **OPERATING INCOME/EXPENSE STATEMENT:**

# **INCOME:**

VARIANCE: \$539.12 over budget.

**EXPLANATION:** 

The category is over budget due to the receipt of funds for the Pool Access Cards.

# **ADMINISTRATIVE EXPENSES:**

VARIANCE: \$4,660.00 under budget.

**EXPLANATION:** 

The category is under budget as expenses did not meet allocation.

# **UTILITY EXPENSES:**

VARIANCE: \$113.78 over budget.

**EXPLANATION:** 

The category is over budget as the Water & Sewer invoice exceeded allocation.

# **GROUNDS MAINTENANCE:**

VARIANCE: \$4,300.85 over budget.

**EXPLANATION:** 

The category is over budget due to necessary repairs to the irrigation system.

# **BUILDING & GENERAL MAINTENANCE:**

VARIANCE: \$472.72 under budget.

**EXPLANATION:** 

The category is under budget as expenses did not meet allocation.

# **POOL MAINTENANCE:**

VARIANCE: \$6,441.28 under budget.

**EXPLANATION:** 

This category is under budget though the Pool Maintenance & Repair and Pool Supplies Line Items exceed allocation.

# **RESERVE EXPENSES:**

VARIANCE: \$11,532.34 over budget.

#### **EXPLANATION:**

This category is over budget due to the replacement of one of the nine pool filters, replacement of the door on NTP pump room and expenses related to the parking area.
