OPERATING BALANCE SHEET:

Assets

- ❖ Pre-paid Insurance: \$7,382.60 is the amount paid to the insurance company prior to the renewal date of August 1, 2025.

❖ Accounts Payable: \$17,115.79 the "open payables" at months' end, which means that invoices for expenses incurred during the month were keyed; however, paid the following month.

- ❖ Total Net Income: \$144,799.57 is the amount of income over expenses at month's end.

OPERATING INCOME/EXPENSE STATEMENT:

INCOME:

VARIANCE: \$929.53 over budget.

EXPLANATION:

The category is over budget due to the receipt of a Pool Access Income.

ADMINISTRATIVE EXPENSES:

VARIANCE: \$2,866.81 over budget.

EXPLANATION:

This category is over budget due to payment remittance of invoices to Mullen & Wylie; as well as, Bolton & Menk.

UTILITY EXPENSES:

VARIANCE: \$555.98 under budget.

EXPLANATION:

This category is under budget as expenses did not meet allocation.

GROUNDS MAINTENANCE:

VARIANCE: \$16,717.15 under budget.

EXPLANATION:

This category is under budget as expenses did not meet allocation. The credit in the Tree Maintenance line item for the month is due to accruing the expense of this service as United has not submitted an invoice.

BUILDING & GENERAL MAINTENANCE:

VARIANCE: \$3,624.29 under budget.

EXPLANATION:

The category is under budget as expenses did not meet allocation.

POOL MAINTENANCE:

VARIANCE: \$4,118.73 over budget.

EXPLANATION:

The category is over budget due to the installation of the exhaust fan in the pool pump room; as well, as the ladies room sink assembly.
